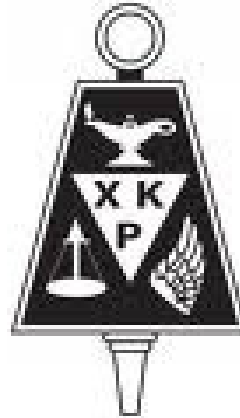

First Vice President/President Elect

This begins the "Presidential Series" and requires a three-year commitment: First Vice President, President, and then Past President. This officer is the liaison between the Board and the committee chairs who oversee the Chapter's non-social general membership meetings.

Prerequisite: Executive Board or Committee Chair experience

Second Vice President

This Officer serves as the membership chair and maintains chapter involvement files; develops the annual membership brochure; and solicits, inducts & introduces new members to Gamma Chapter.

Recording Secretary

This Officer records and distributes the minutes for all Executive Board meetings; in coordination with President distributes meeting agendas and meetings schedules and provides other correspondence as needed.

Corresponding Secretary

This Officer maintains the Chapter membership list; distributes mailing list, and handles other communications (email blast) for Chapter events and activities.

Treasurer

This Officer receives and deposits all monies, maintains appropriate records for all Chapter funds, prepares monthly financial statements, and initiates dues renewals.

National Delegate

This Officer attends National Board meetings, reports on Chapter and National concerns, submits Chapter information for the National newsletter, and takes the lead on the Helen I. Pontius nomination papers.
